- Absolutely No Smoking and No Open Fires.
- No BBQs or Other On-site Food Preparation.
- No Alcoholic Beverages.
- Hours of Use: 11 AM to Sundown Unless Otherwise Approved.
- Maximum Duration of Use: 6 Hours.
- Remove All Trash and Belongings. Leave it cleaner than when you arrived.
- Supervise Children and Stay Clear of the Escarpment Edge.
- No Pets.
- Respect the Peace and Quiet of Nearby Residents. Stay on public property and pathways. No loud music or noise. Do not block driveways.
- Maximum Attendees: 50.
- Maximum Vehicles: 10. Please carpool and use shuttles.
- Do Not Feed Wildlife.

Fees. Property Owners and residents in the Loughill Village Park and Recreation District: \$100 Security Deposit. Non residents of the District: \$100 Use Fee plus a \$100 Security Deposit.

All users understand and agree that Loughill Village Park and Recreation District shall not be responsible for property damage or personal injury sustained by any person as a result of using Inspiration Point.
